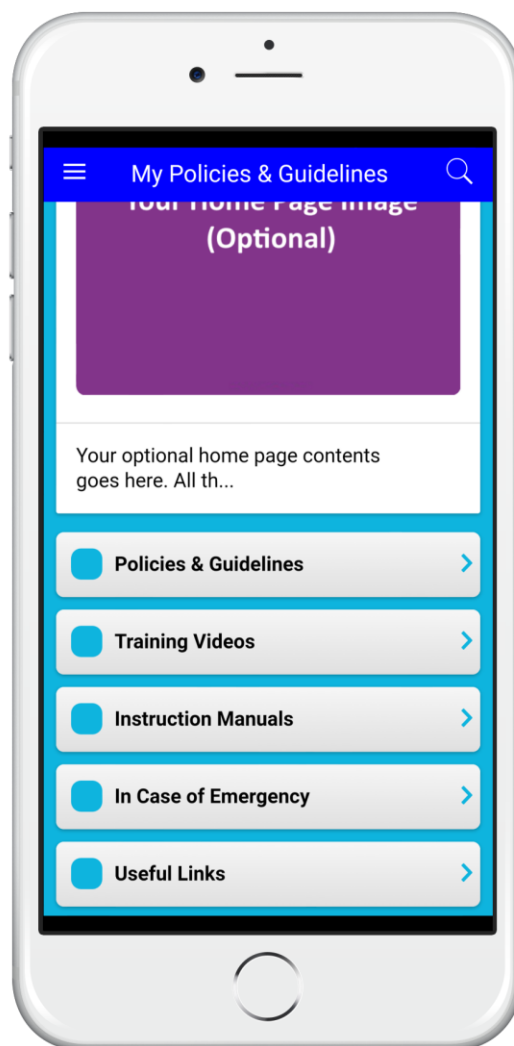

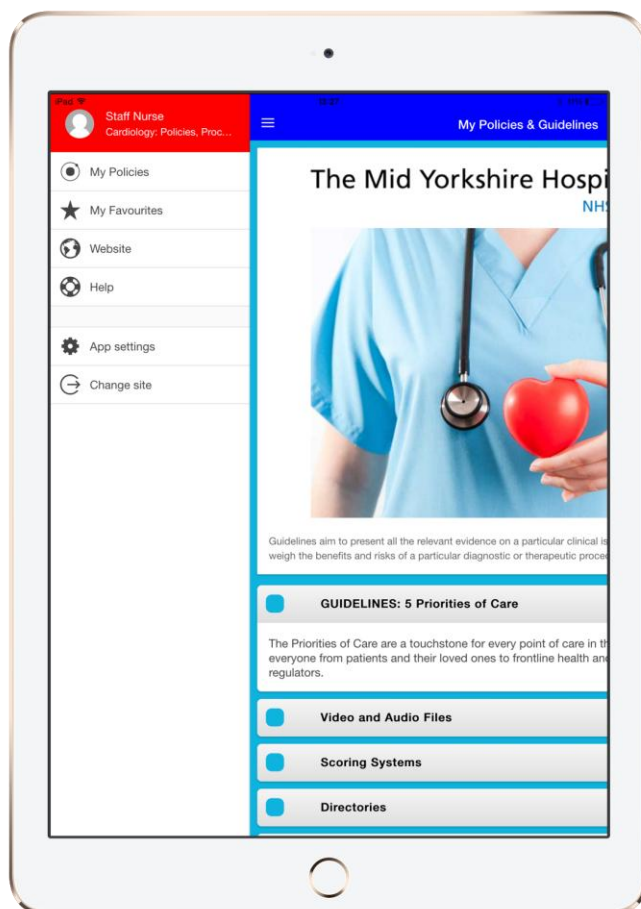
APP Screen Shot - Home Page

APP Home Page - Tablet View



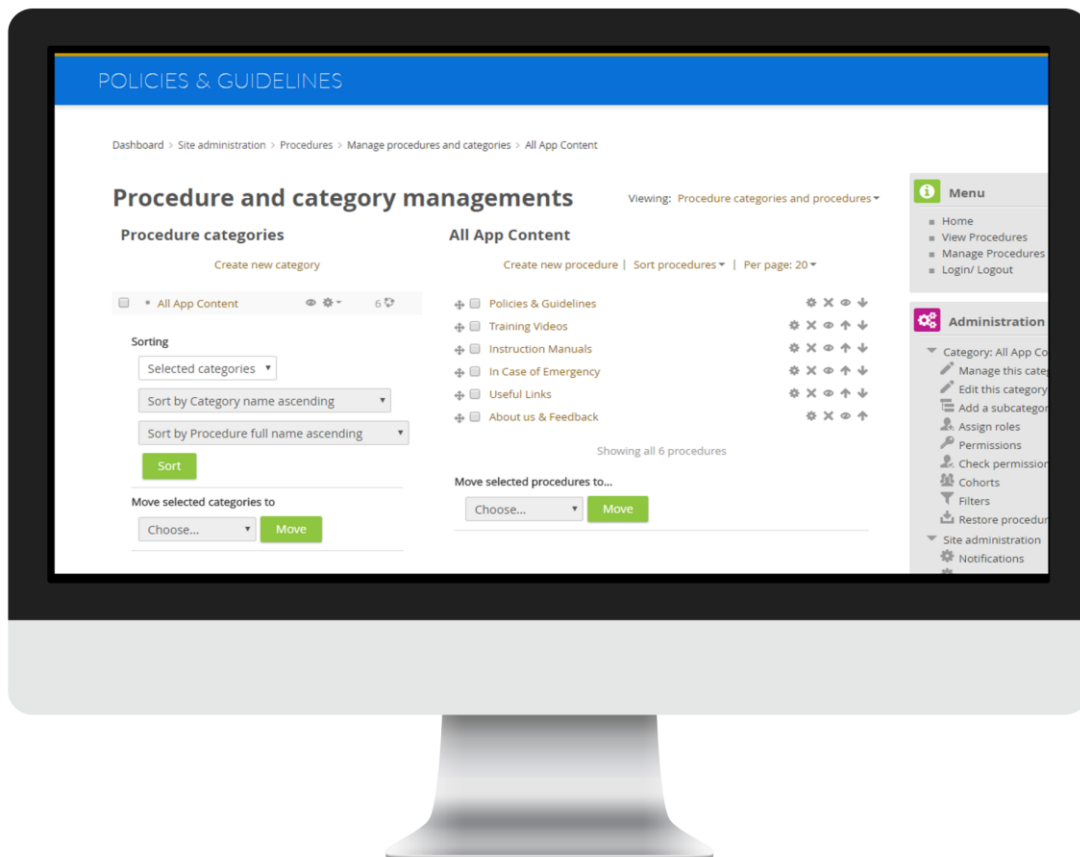
Supports Surveys, All Media & Document Formats

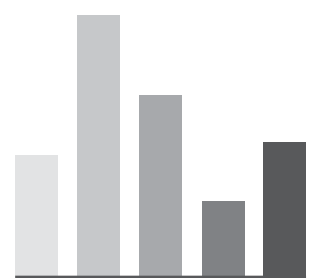
